SECTION 2ND The Mayor is authorized to execute and file with such applications and assurance or any document required by the "Rural Development Agency".

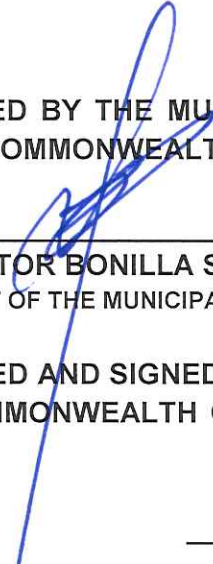
SECTION 3RD The Mayor is authorized to execute and file with such applications and assurance or any document required by the "Rural Development Agency".
