“RESOLUTION AUTHORIZING THE FILING OF APPLICATIONS WITH THE FEDERAL TRANSIT ADMINISTRATION, AN OPERATING ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF TRANSPORTATION, FOR FEDERAL TRANSPORTATION ASSISTANCE AUTHORIZED BY 49 U.S.C. CHAPTER 53, TITLE 23, UNITED STATES CODE, OR OTHER FEDERAL STATUTES ADMINISTERED BY THE FEDERAL TRANSIT ADMINISTRATION FOR THE COLLECTIVE TRANSPORTATION PROGRAM WITHIN THE MUNICIPALITY OF SAN LORENZO.”

WHEREAS: Article 1.003 of Act Number 107-2020, as amended, known as the "Puerto Rico Municipal Code," declares it a public policy of the government of Puerto Rico to provide municipalities with the powers and faculties necessary so that they can assume their fundamental role in favor of the social and economic development of their jurisdictions. For its part, Article 1.007 recognizes municipal autonomy in the exercise of its legal, economic and administrative powers over matters relating to the general welfare of its inhabitants. Municipal autonomy shall be exercised without impairing the powers and faculties of the Legislative Assembly to determine the regime and function of the municipalities, as provided in Section 1 of Article VI of the Constitution of Puerto Rico. The Legislative Assembly of Puerto Rico shall grant the necessary and convenient powers to the municipalities to exercise said autonomy, in accordance with the legal system in force.

WHEREAS: Article 1.039 of Act 107 provides that the Municipal Legislature shall exercise the legislative power in the municipality and shall have the powers and duties on local matters conferred to it in this Code, as well as those incidental and necessary thereto, among which subsection (m) establishes that it shall approve those ordinances, resolutions and regulations on matters and subjects of municipal competence or jurisdiction that, pursuant to this Code or any other law, must be submitted for its consideration and approval.

WHEREAS: The Federal Transit Administrator has been delegated authority to award federal financial assistance for a transportation project.

WHEREAS: The grant or cooperative agreement for federal financial assistance will impose certain obligations upon the applicant, and may require the applicant to provide the local share of the project cost;

WHEREAS: The applicant has or will provide all annual certifications and assurances to the Federal Transit Administration required for the project;

THEREFORE: BE IT RESOLVED BY THE MUNICIPAL LEGISLATURE OF SAN LORENZO, PUERTO RICO, THAT:

SECTION ONE: That Mayor is authorized to execute and file an application for federal assistance on behalf of the Municipality of San Lorenzo with the Federal Transit Administration for federal assistance authorized by 49 U.S.C. Chapter 53, title 23, United States Code, or other federal statutes authorizing a project administered by the Federal Transit Administration. The Mayor is authorized to execute and file Urbanized

Area Formula Program assistance authorized by 49 U.S.C. 5307, either alone or in addition to other federal assistance administered by the Federal Transit Administration, as the Municipality of San Lorenzo has received authority from the designated recipient to apply for Urbanized Area Formula Program assistance.

SECTION TWO: That Mayor is authorized to execute and file with its applications the annual certifications and assurance and other documents the Federal Transportation Administration requires before awarding a federal assistance grant or corporative agreement.

SECTION THREE: That Mayor is authorized to execute grant and cooperative agreements with the Federal Transit Administration on behalf of the Municipality of San Lorenzo.

SECTION FOUR: Derogative Clause: If any Ordinance, Resolution, Agreement or part of them conflicts with this Resolution, that ordinance, resolution, agreement or part of them that is in conflict, shall be hereby derogated.


SECTION FIVE: This Resolution shall be in effect once signed by the Legislature Municipal Board and the Mayor of San Lorenzo.


